Spring is a time for renewal and our biggest news is that we have 'renewed' our Land Acknowledgement. We will use our new version to open Council meetings, our AGM and any other event as deemed appropriate by CDHM.

Our new Land Acknowledgement reflects a snapshot in time where Council gathered with facilitators Faye Tardiff & LaRaine Seivewright from WRHA to ponder, explore and create. The version chosen by Council was sent to the Treaty Relations Commission for feedback. With their help our Land Acknowledgement was finalized. While the final version is very important, so was the time spent on the journey to get there. We consider this a 'living' statement and as such it will be added to our Council Calendar to ensure regular review.

"CDHM is located on the original lands of the Indigenous peoples of Manitoba, which includes the Anishinaabeg, Dakota Oyate, Inninewak, Anishinini, Dene, and Inuit and the homeland of the Red River Metis nation. We acknowledge that Winnipeg receives its drinking water from Shoal Lake 40. We recognize Treaties 1-6 & 10 that created relationships between Treaty partners and that the agreements they made were intended to be mutually beneficial. We are committed to collaborating with Indigenous communities in the shared spirit of truthtelling for the healing and inclusion of all who share the land." Linking and connecting with Manitobans to hear about their oral health concerns seems simple, however, it has proven to be challenging. Council continues to make progress in its understanding of what linkage work entails. For the first time, in collaboration with a Governance Coach, Council has framed the beginnings of a multi-year linkage plan. Seniors aging in place in in rural communities will continue to be the focus for 2024. As I reflect on how much time Council has put into understanding its role in linkage work, I am reminded of a quote by Steve Jobs.

## *"If you look really closely, most overnight successes took a long time"* - Steven Jobs, Co-Founder, Apple Inc.

We are now thinking ahead to those whose terms on Council will be ending, the current needs of Council, and how, through appointments (public reps) and nominations (RDHs), we will fill gaps that will result in a well-rounded Council. Stay tuned for updates on Council vacancies.

#### JANUARY 11TH, 2024 5:30PM-8:30PM

- Chair, Kathleen Reid, reviewed policy GP-2 with Council.
- Faye Tardiff and LaRaine Seivewright from the WRHA, facilitated small and large group discussions around the creation of a Land Acknowledgement. Three drafts were produced for Council's final review.

At the CDHM office we are pleased to report that RDHs are also welcoming the new CCP format and are pursuing many opportunities for professional development.

We would like to remind registrants that if you have questions about the new format, we have an updated <u>CCP Guidebook</u> outlining the expectations and the updated activity categories. If you don't find the answer there, we are happy to answer them via a phone call or email.

Here are a few answers to common CCP queries:

• CDHA courses and webinars can be applied to the CDHM CCP; courses offered by provincial, state, national, and international dental hygiene and dental regulatory authorities, associations, and their component societies can be applied so long as the course content is within CDHM Scope of Practice.

- Many of the 2024 MDA Convention lectures can be applied to the CDHM CCP. See the list <u>here</u>, and note that the lecture titled, "Digital Scanning for the Dental Team", by Dr. Amarjit Rihal, was also recently added.
  - Lectures/Presentations are eligible for 1 CC hour.
  - CPR BLS cannot be applied to CCP.
  - Manitoba Case Studies Panel Discussioneligible for up to 2 CC hours.
- Dental Hygiene Legislated Competencies and Course Objectives are used for determining applicability of course content to RDH scope of practice.
- One professional RDH Annual General Meeting (AGM) can be applied, per CCP year. If the AGM includes a Keynote speaker or educational/presentation component, this can be applied separately.

We appreciate all questions and feedback as we continue to streamline the CCP process.

#### "Good things come to those who wait." -English Proverb

While this quote may be true, I, like many of you, am wondering exactly how long do we have to wait before we transition to the Regulated Health Professions Act? We are prepared and look forward to the process when it is our turn.

In the meantime, the CDHM continues to work to facilitate safe competent dental hygiene care for all Manitobans, including those who live in First Nation Communities. A letter to the Minister of Health. requesting an amendment to the practice setting restrictions listed in the Dental Hygienists Act, was successful and through collaborative efforts with the Dakota, Ojibway Tribal Council (DOTC) community of Bird Tail Sioux, dental hygiene services are now being offered onsite. We are now awaiting Ministerial response regarding our request for an amendment to settings restrictions, permitting dental hygiene services in the communities of the Southeast Resource Development Council Corporation (SERDC). A Zoom Info Night for RDHs considering working in alternative practice settings will be held soon. Watch your email for more details in the coming weeks.

We are currently working with Doretta Harris, who is the Regional Lead – Indigenous Health Southern Health, to create an Indigenous cultural safety & humility module for the CDHM. This module will be completed in June and required for registrant registration renewal in 2025.
