

### Chair's Report—Mickey Emmons Wener

During the fiscal year May 2009 to April 2010, four full-day CDHM Council meetings were held on: May 4/09, Aug 31/09 Nov 9/09, Feb 1/10. An Open House on Nov 9/09 celebrated the establishment of the CDHM office at 109-420 Des Meurons.

### Sept 26/2009 Annual General Meeting

- Reports were provided by the Chair, Registrar/ED, and Chair of the Complaints Committee. A number of by-law changes were successfully passed in order to provide clarity, describe Council Members roles more succinctly, and to synchronize the by-laws with policies established as part of CDHM Policy Governance. Two Council members were elected, including a new member, Terry Phillips, and the return for another term by Patti Hawthorn.
- The well-attended meeting focused on Continuing Competency (CC) including a Quality Assurance
  presentation by Joanna Asadoorian, and a CC Committee report which laid out a possible structure.
  All members present had the opportunity to provide feedback on the CC program prior to it going
  further.

### **General Activities:**

- The CDHM continued to meet requirements regarding regulation, registration and complaints.
- The following committees were maintained: Continuing Competency, Complaints, Inquiry, Nominations, and several working subcommittees.
- Adhering to our Policy Governance model, Ends/Outcomes were determined and monitored.
   Financial accountability was ensured.
- The CDHM adopted the current Commission on Dental Accreditation of Canada's (CDAC) list of accredited dental hygiene programs as the CDHM list of approved programs.
- Feedback was provided on a National Entry-to-Practice Dental Hygiene Competencies document.
- On-going communication occurred with registrants, employers and the public via the CDHM website, the newsletter (CDHM Connections) and televised public service announcements.
- On-going orientation and training of new Council members and employees was conducted.
   Orientation policies were established.

### **Initiatives:**

- Numerous Continuing Competency Program orientation sessions were provided in various provincial locations.
- A CDHM Registered Health Professions Act (RHPA) Strategic Planning Working Group was
  established, that included representatives from the Manitoba Dental Hygienists Association and
  University of Manitoba School of Dental Hygiene.
- Consultation regarding the student-run WISH Clinic at Mt Carmel Clinic was held with the University
  of Manitoba School of Dental Hygiene WISH clinic students and Director to ensure supervision
  requirements were met. CDHM co-authored a presentation at the International Symposium of
  Dental Hygiene in Glasgow Scotland and supported the students presenting.

### Ongoing and Upcoming Organization/Committee Participation:

- Participation and legislative discussions with the Manitoba Health Profession Regulators group and MB Health in regard to the RHPA and The Fair Registration Practices in Regulated Professions Act.
- Liaison with the Canadian and Manitoba Dental Hygienists Associations.
- Oct/10 Council participation in National Dental Hygiene Certification Board ownership linkage activities in Winnipeg.

### Transitions:

In April/10, following three years of valued service, Kellie Hildebrandt, Registrar/Executive Director, resigned effective June 25/10. The month of April was the beginning point for a national search for a new Registrar/Executive Director.

The CDHM Council, the Registrar/ED, employees and committee members continue to act responsibly and proactively on behalf of Manitobans to help ensure quality dental hygiene care.

### **CDHM Statistics**:

- 88% of RDHs have either passed the NDHCE or been grand-parented.
- 80% of RDHs graduated from the University of Manitoba, School of Dental Hygiene.
- 84% of RDHs have a membership with MDHA/CDHA.
- Of the RDHs that are practising:
  - 83% are on the Extended Practice Roster
  - 64% are on the Local Anaesthetic Roster
  - 46% are on the Orthodontic Roster
  - 56% are on the Restorative Roster

### Registrar - Executive Director's Report

It has been another very eventful and exciting year for the College of Dental Hygienists of Manitoba. Some highlights to note include settling into our inaugural office space in July 2009, holding a successful 2<sup>nd</sup> Annual General Meeting in September 2009, working diligently on the development of a Clinical Competency Assessment for new registrants and the Continuing Competency Program, and increasing the human resources capacity in the office.

- Virginia Bagshaw was hired as the Registration/Program Coordinator in March 2010 and has been an invaluable asset to the CDHM.
- Sheryl Sloshower joined the College as the Continuing Competency Program Coordinator in April 2010 with a primary focus of enabling our registrants to achieve their ongoing learning and professional goals and objectives.
- Tara Kinchen has been contracted as newsletter editor to create documents that will help to inform our members of important issues in the field of dental hygiene.
- Mickey Wener has been contracted as the Extended Practice Program Coordinator to assist dental
  hygienists explore alternative practice settings with the ultimate goal of offering dental hygiene
  knowledge and services to those people that cannot currently access our care.

### **Registration Statistics:**

The Dental Hygienists Act and the Regulations establishes four registers. Effective April 30, 2010 the following statistics pertain to the established registers:

- Register of Dental Hygienists (Practicing): 587
- Register of Dental Hygienists (Non-practicing): 52
- Register of Dental Hygiene Students: 53
- Register of Temporary Dental Hygienists: 0

Since renewal on January 15, 2010 to the end of this fiscal year, April 30, 2010, 6 new applications have been received, reviewed, approved and processed for registration. One new applicant has been denied registration. This applicant was a new graduate from an international dental hygiene program and was unsuccessful on the CDHM Clinical Competency Assessment.

### Unauthorized Practice:

During this fiscal year, one individual was accused of unauthorized practice. This individual was not educated in dental hygiene and thus, was in contravention of *The Dental Hygienists Act* 2(1), 2(2), 3(1), and 3(2) in that she was practicing as a dental hygienist, representing herself as a dental hygienist, and using the title "dental hygienist". The CDHM sent notices to this individual and her employer requesting that she cease from these activities. The accused individual responded in writing that she has retired and would not be practicing in any other office. Her employer responded in writing indicating that they were unaware of her status and that she was no longer employed in that office or any affiliated entity. Legal counsel to the CDHM advised no further action be taken and the name of the individual not be released since legal prosecution was not needed.

### Complaints and Disciplinary Action:

One anonymous complaint was received regarding the clinical practices and protocols of a registered dental hygienist. The individual involved was contacted and information verifying her protocols was requested. This complaint was resolved informally. No member was disciplined in this fiscal year.

### National Dental Hygiene Examination (NDHCE)

Effective January 2009, the CDHM requires successful completion of the NDHCE by all new registrants. As a result of the regulatory requirement, the CDHM holds a position as Governor on the National Dental Hygiene Examination Board of Governors. During this fiscal year, the Board met three times; May, September and December 2009. The next meeting of the Board is to be held in Winnipeg in October 2010.

### **Continuing Competency Program:**

We are proud to report that in April 2010, the Continuing Competency Program (CCP) was officially launched. The key objective of this program is to advance the collective knowledge and quality of care offered by all hygienists in Manitoba, thus assuring protection of the public's interest. In February 2010, an Open Forum Feedback Session was held to gather comments, information and suggestions from members regarding the proposed CCP. The session was very well attended and a significant amount of valuable information was gathered. Revisions to the CCP were made as a result of this feedback and it was officially introduced to the membership through multiple Information Sessions offered in May 2010. Sheryl Sloshower was hired part-time as the Continuing Competency Program Coordinator and is responsible for the ongoing development and monitoring within the program.

### Registrar's Report - Continued

### Federation of Dental Hygiene Regulatory Authorities (FDHRA)

The CDHM is a current member of the FDHRA, which meets once per year and discusses issues that relate and affect all dental hygiene regulatory authorities across Canada. The last meeting of the FDHRA was held in Halifax in September 2009 and is scheduled for September 2010 in friendly Winnipeg, Manitoba.

### Health Professions Regulatory Reform Initiative (HPRRI)

The Regulated Health Professions Act (Bill 18) (RHPA), also referred to as 'umbrella legislation' was introduced in the legislature on April 16th, 2009 and received royal assent on June 18, 2009. This Act has been developed by the government as a single common statute to govern all regulated health professions. It will replace all the individual statutes that currently govern health professions, including The Dental Hygienists Act. The transition to The Regulated Health Professions Act will occur for all regulated health professions, including the CDHM over the next few years. Discussion and preparation for this transition has begun within the CDHM by the formation of the RHPA Working Group.

### Competency Assessment and Refresher (CAR) Working Group

Individuals from the CAR working group have been reviewing other provincial dental hygiene Clinical Competency Assessments and have met to discuss the needs and goals for the Competency Assessment and Refresher Programs for Manitoba. These programs are being developed in order to assess and ensure competence for individuals who have been out of dental hygiene practice for more than three years, individuals who have not met the minimum practice hours required in a three year period or graduates of international dental hygiene programs. The CDHM Competency Assessment was offered for the first time to an international graduate in April 2010. Revisions and development continue on both the Competency Assessment and Refresher Programs.

### MDA Oral Health Team Committee (OHTC)

The OHTC is a group comprised of dentists, dental hygienists, dental assistants and dental therapists that meet to discuss and review scope of practice issues relating to the dental professions. Representatives from the MDHA and CDHM serve on this committee. Terms of Reference for members of this committee are being reviewed at the present time by the MDA.

### **Fair Registrations Practices Act**

The Fair Registration Practices in Regulated Health Professions Act received royal assent on November 8, 2007. As a regulated health profession, the CDHM must adhere to this Act and submit reports and monitoring to the Fairness Commissioner on a regular basis. Several foundational meetings have been attended this year and we continue to work very closely with the Office of the Manitoba Fairness Commissioner to ensure all programs or services offered by the CDHM meet are in compliance with this Act. During this fiscal year, The Fairness Commissioner provided a grant of \$8000.00 to assist in the continued development of the Competency Assessment and Professional Preparation/Refresher courses.

### Open House for the New Office Space

On July 1, 2009, the College proudly opened the doors to a facility that provides formal offices for employees, a meeting space for Council, committees and working groups. An Open House was held in in November 2009 to welcome members, government and related MB Health Professions.

### **Public Service Announcements**

Two public service announcements were created to inform the public of the roles and responsibilities of dental hygienists and to educate the people of Manitoba regarding the link between oral health and overall health. The announcements aired in April 2010 for National Dental Hygienists Week and Oral Health Month.

### **By-Law Adjustments**

To align the bylaws with current, exemplary governance practices the by-laws were adjusted to eliminate duplication between the bylaws and our policies, and to increase efficiency and effectiveness of the College. New copies of the by-laws were sent to the registrants in January 2010.

### 1. PURPOSE

The College of Dental Hygienists of Manitoba is the self-regulating body for the profession in Manitoba. The College provides services to its membership and governs its members in a manner that serves and protects the public interest.

The College was incorporated under The Dental Hygienists Act of Manitoba. As a not-for-profit organization, the College is exempt from tax under the Income Tax Act.

### 2. SIGNIFICANT ACCOUNTING POLICIES

The financial statements have been prepared in accordance with Canadian generally accepted accounting principles and include the following significant accounting policies

- (a) The Unrestricted Fund accounts for the College's program and administrative activities. Contributions are recognized as revenue of the fund in the year received or receivable if the amount to be received can be reasonably estimated and collection is reasonably assured.
- (b) The capital asset fund represents the College's investment in computers, software, equipment and leasehold improvements. Depreciation is recorded as an expense of the capital asset fund.
- (c) Interest income is recorded on an accural basis.

### (d) Capital assets

The capital assets are recorded at cost. Depreciation has been recorded in the accounts to amortize the cost of the capital assets over their estimated useful lives and the rates applied are as follows

Computers and software

Equipment

Leasehold improvements

20% diminishing balance 20% diminishing balance

20% straight-line

No depreciation is recorded in the year of acquisition.

### (e) Financial instruments

The fair value of cash and accounts payable and accured liabilities is approximately equal to their carring value due to their short-term maturity.

### (f) Estimates

The preparation of financial statements, in accordance with Canadian generally accepted accounting principles, requires management to make estimates and assumptions that affect the reported amount of assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. These estimates are reviewed periodically, and, as adjustments become necessary, they are reported in earnings in the period they become known. Actual results could differ from these estimates.

### (g) Contributed services

The work of the College is dependent on the voluntary services contributed by many members. Contributed services are not recognized in the financial statements because of the difficulty in determining their fair value.

(h) New accounting standards

A number of standards applicable to non-profit organizations were amended to improve the consistentcy of reporting and presenting the financial information where the circumstances were similar to those of profit oriented enterprises. The new standards are effective for fiscal years beginning on or after January 1, 2009.
