Currently, there is a call for nominations to fill two Registered Dental Hygienist positions. If you are committed to improving oral health care in Manitoba, this Council position may be for you!

As I continue to serve, I will seek guidance from the knowledge and experience of my fellow Council members as well as that of our Registrar. Together, we remain on this important journey in the hopes of advancing the oral health care of all Manitobans.

THURSDAY MAY 25TH 2023 5:30-8:30PM

Kathleen also reminded Council of the importance of their role in Ownership Linkage and ENDS development.

FROM THE DESK OF THE DEPUTY REGISTRAR

Is your Professional Liability Insurance (PLI) up to the task?

Registered professionals need to be able to respond to a statement of claim threatening legal action alleging professional negligence, error, or omission.

Did you know that a complaint can be made to the CDHM against a registrant up to 5 years after the RDH has left the profession (retired, cancelled registration, or discontinued practice)? It is important to know how you are covered.

Some things to know about your policy include:

Does it cover?

- Legal defense costs
- Full scope of practice no requirement to practice under the direction/supervision of a dentist
- Damages/Patient Compensation/Settlement
- Extended Reporting Period (ERP) Coverage*

When you are shopping for your PLI, it is important to consider whether a deductible may be required for claims.

Check with your policy holder to ensure you are covered appropriately.



Insurance is peace of mind, but make sure you understand your coverage!

*ERP is for claims that are first discovered and filed after you have retired and/or discontinued practice with respect to acts, errors, and omissions committed while you were actively practicing and prior to the expiry of you last active policy

PLI is typically a 'claims-made' based insurance, meaning the hygienist must have coverage when the claim is made as opposed to when the incident took place.
