## Registrar's Report - Stephanie Gordon

### ***New On-Line Registration***

The CDHM is excited to announce that it will begin using a new computer management system as of October 1, 2015 for registration. The transition from the old paper-based system to the new system will require registrants to access the system on-line. A User ID and temporary password will be sent to each registrant by email when the new data base is activated. Once the new system is in place, you must use the new User ID and the temporary password the first time you sign in to the CDHM website. On sign-in you will be given the option to reset the password to one that is easier for you to remember. When practising members renew online, the registrant will be required to upload two documents. 1) a PDF copy of the registrant's liability insurance and 2) a photocopy of a CPR card (Level C or Health Care Provider) taken in the previous 12 months.

Non-Practising registration may be renewed online as well. Non-Practising members are not required to provide evidence of holding CPR certification or of meeting liability insurance requirements.

### **Your Responsibility**

- Make sure the CDHM has your correct name, email and postal addresses, home telephone and/or cell number, current employer address and telephone number.
- Practising registrants must complete the renewal on-line including evidence of current CPR certification and liability insurance and fees, by **December 1, 2015** even if they fail to receive a renewal notice from the Registrar. After December 1, 2015, a late fee will apply.
- Non-Practising registrants must complete the renewal on-line including full payment of fees, by **December 1, 2015**, even if they fail to receive a renewal notice from the Registrar. After December 1, 2015, a late fee will apply.

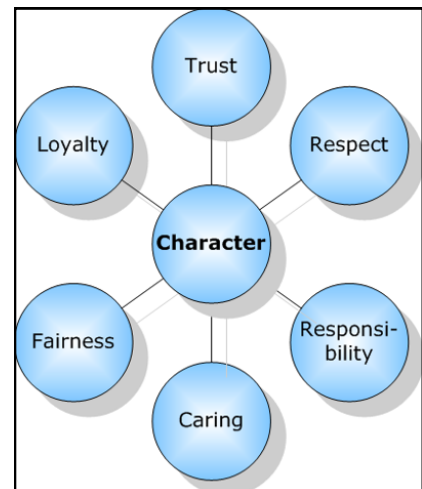

## Deputy Registrar's Update



The College of Dental Hygienists of Manitoba (CDHM) has adopted the Policy Governance® Model created by Dr. John Carver, which is an operating system for governing Councils. This model enables the CDHM Council to provide strategic leadership empowering the management while at the same time assuring accountability. Most importantly, this model enables Council to conceptualize, organize and fulfill its mandate of ensuring the public has access to safe, competent and ethical dental hygiene care in all practice settings. In June, I had the opportunity to attend the International Policy Governance Association (IPGA) conference in Vancouver. Two Council members, the Registrar and I engaged in the IPGA conference for a three-day learning session gaining valuable knowledge for me in my new role as the Deputy Registrar. Notably, this conference was well attended by many of the dental hygiene regulatory bodies throughout Canada. The dental hygiene profession has embraced the Policy Governance® Model. Consequently, dental hygiene was the single largest profession in attendance at the IGPA Conference.

During my time in Vancouver, I also participated in an "Owner Linkage" session, hosted by the National Dental Hygiene Certification Board (NDHCB). It was attended by regulators, council members and educators so that the NDHCB could gain valuable input on current trends and issues impacting the dental hygiene profession and the national dental hygiene certification process.

Subsequently, I would like to inform you that Canadian Quality and Patient Safety Week is taking place from October 26-30, 2015. During Canadian Quality & Patient Safety Week, the WRHA and the Manitoba Institute for Patient Safety (MIPS) are partnering on two patient safety forums. Registration opens on September 1, 2015 on the MIPS website at: <http://mips.ca/>. The CDHM strongly supports quality and patient safety week, and encourages all registrants to support these important events. Please go to the CDHM website at: [www.cdhm.info](http://www.cdhm.info) for further information regarding the patient safety forums and how you can obtain valuable patient safety material for your dental hygiene practice from MIPS.

Specifically, on how safety impacts the practice of dental hygiene, the guiding principle in the *CDHA Entry-To-Practice Competencies and Standards for Canadian Dental Hygienists* states: "Safety includes all steps and or actions by a dental hygienist that will prevent harm, and if harm is present reduce or minimize the harm. This includes such things as infection control procedures, risk management strategies and ensuring competent delivery of dental hygiene services. Maintaining a culture of safety involves ensuring health and safety in the workplace, homes and communities. **Safety goes beyond the direct relationship with the client and needs to include attention to personal wellbeing, and recognition of impaired abilities by the dental hygienists.**"

"Safety is enhanced when professionals work cooperatively and communicate effectively. Safety incorporates more than the physical components associated with infection control and technical competence as it also incorporates an attitude that relies on the critical thinking abilities of the practitioner to place the client's wellbeing at the centre of the equation. If the dental hygienist does not practice with a collaborative mind-set or one that advocates for the client's access to health care then the client may be "in danger" of slipping back into an unsafe state of being."

If quality and safety are areas of your dental hygiene practice that you would like to enhance, I urge you to look at the *CDHM Practice Standards and Competencies*, *CDHA Entry-To-Practice Competencies and Standards for Canadian Dental Hygienists* as well as the *CDHA Code of Ethics* to find pertinent information regarding dental hygiene care and safety. Consider making quality and safety a priority in your lifelong learning by creating your continuing competency goal on advancing patient safety.

In closing, I would like to congratulate the registrants who were audited for the 2014-2015 Continuing Competency Program (CCP) year, and I would also like to extend my heartfelt gratitude to the CCP Reviewers for their dedication and hard work.

## Insights into the CCP Review Process

Completing my second year as a Continuing Competency Program (CCP) Reviewer with the College of Dental Hygienists of Manitoba (CDHM) has been a very rewarding experience. After applying for the CCP Reviewer position last year, I was accepted by the CDHM to be a mentee of Ms. Sheryl Slosower, the CCP Coordinator.

I am encouraged as a new RDH by the dedication Manitoba dental hygienists have towards their work and competence as oral health professionals. It was fascinating to read through the goals registrants set and see how each followed through to obtain the highest quality evidence to achieve their goals and improve the quality of care they provide.

As a recent student of the School of Dental Hygiene at the University of Manitoba, my peers and I had the benefit of a CCP workshop with Ms. Sheryl Slosower to prepare us for submitting accurately completed CCP documents following our graduation. She covered the information detailed in the CCP Package, and I highly recommend reviewing the package, in addition to the CCP Directives, prior to beginning work on future CCP submissions. To further guide you in completing your submissions, there are examples of a well-written Continuing Competency Record (CCR) and a Professional Activity Record (PAR) in the CCP Package.

While reviewing the CCR and PAR submissions for this 2014-2015 CCP year, I noted several common and easily correctable errors. In order to assist you with future CCP submissions, below are some of the key errors.

- Goals established must be SMART, by being Specific, Measurable, Achievable, Realistic, and Time-specific. Additionally, goals should be concise and contained within one sentence. An example of an appropriately formulated goal is: Within 6 months, I will use ultrasonic/power scalers in my dental hygiene practice in accordance with the most recent research/evidence.
- All Continuing Competency (CC) activities must be evidence-based. One of the best ways to formulate an evidence-based submission is to use relevant, up-to-date, and professionally reputable sources. Non-professional magazines, books, and journals cannot be used as CC activities.
- Discussions with colleagues, employers, other health professionals and product representatives cannot be used as CC activities as they are opinion based, not evidence-based and may be biased. Further clarification on this point can be found on the CDHM's website at <http://www.cdhm.info/quality-care/ccp-directives/>
- In order for CCP Reviewers to evaluate the learning that has taken place, thoroughly describe the information and knowledge gained from the CC activities (point 2 in the Activity Implementation & Evaluation section of the CCR form).
- All activities must have been completed within 24 months prior to the reporting period deadline (April 30<sup>th</sup>) to be included as activities on the CCR and PAR forms.
- Study groups are an excellent way to collaborate with colleagues and work towards a common goal. The CDHM encourages group learning. However, the CCR is a self-directed learning process. Hence, one's personal learning experience must be in one's own words. Each year, it is essential to inform the CDHM of the study group topic and members.
- Time taken to complete the CCR and PAR forms cannot be included in the time spent working towards the goal.

I look forward to working with the CDHM next year as a CCP Reviewer.

Ms. Sheryl Slosower and all the CCP Reviewers would like to congratulate the registrants who were audited for the 2014-15 CCP year. This year, as in previous years, there were exemplary CCR and PAR submissions. Moreover, we would like to acknowledge the admirable effort put forth by all the registrants.

Please note that Ms. Sheryl Slosower will meet one-on-one with registrants who may need guidance and assistance when completing the CCP submissions.

## From Your Council

The purpose of an Ownership Linkage committee is to help identify the trends and issues that could assist the Council in policy development. Given that the policies are actually instructions to the Registrar about what has to be accomplished, they need to be future-focused and appropriate for a provincial regulatory body. Given the Council is also morally accountable to the people of Manitoba, we can achieve this by dialoguing directly with the public stakeholders- not to be confused with “members”- to focus attention on external trends and issues. Last fall at the Annual General Meeting, the Ownership Linkage committee surveyed one segment of the public- dental hygienists- and we wanted to thank you for your thoughtful consideration to the presented questions. We have organized and reviewed the responses and wanted to let you know some of the general themes that emerged.

1. In order to ensure that the College continues to promote the value of oral health and the role of the dental hygienist, you encouraged continued focus and work towards positive evidence-based changes in legislation to further progress dental hygiene. Practice audits, standardized methods of continuing education, public forums, collaboration with MDHA and the University of Manitoba (to ensure standardized access to information) and strong communication with dental hygienists were identified as methods the CDHM could use to ensure this is happening.
2. Education requirements for entering the profession, increased technology and the use of social media were identified as trends.
3. Lack of public awareness, decreased inter-professional collaboration, lack of funding for programs aimed at under-served populations, and dental hygienists themselves were identified as barriers in achieving progress in the dental hygiene discipline.

The committee will continue to liaise with its public owners to seek perspectives and identify unknown values/issues that could impact future policy development. We look forward to presenting the information from these conversations in the future.

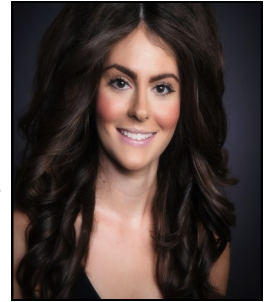

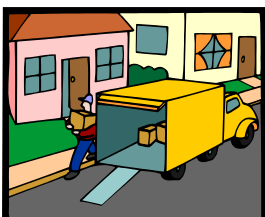
