



Indigenous Cultural Safety Module (2025 Renewal) Survey Results Thank-you for Your Feedback!


1. The information presented by Doretta Harris in the Indigenous Cultural Safety Module was new to me.




2. The length of the Indigenous Cultural Safety Module was appropriate for the topic.
